Corporate Membership公司會員

Corporate Member 基本公司會員:

Companies which are carrying software business with registered office at least 4 years in HK. Members will have the voting right of the Association and the right of being nominated as council members. 從事資訊科技及軟件行業或有關的香港註冊最少四年的公司。會員可享有本會投票及被選權。

Affiliate Corporate Member 聯系公司會員:

Companies or organizations which are interested in software industry but not qualified as a corporate member.

Individual Member 基本個人會員:
