Members will have the voting right of the Association and the right of being nominated as council members. 從事資訊科技及軟件行業或有關係的香港註冊最少四年的公司。會員可享有本會投票及被選權。</p> <p>Affiliate Corporate Member 聯系公司會員： Companies or organizations which are interested in software industry but not qualified as a corporate member. 有興趣發展軟件業務而不符合基本公司會員資格的所有公司及機構。</p>
