## HKSIA Membership Classes 香港軟件行業協會 會員類別

Corporate Membership 公司會員
<b>Corporate Member 基本公司會員：</b> Companies which are carrying software business with registered office at least 4 years in HK. Members will have the voting right of the Association and the right of being nominated as council members. 從事資訊科技及軟件行業或有關係的香港註冊最少四年的公司。會員可享有本會投票及被選權。
<b>Affiliate Corporate Member 聯系公司會員：</b> Companies or organizations which are interested in software industry but not qualified as a corporate member. 有興趣發展軟件業務而不符合基本公司會員資格的所有公司及機構。
Individual Membership 個人會員
<b>Individual Member 基本個人會員：</b> HK permanent residents who are working in software industry. Members will have the voting rights and/or the rights of being nominated as council members. 於香港從事資訊科技及軟件行業或有關係之香港永久居民。會員可享有投票及被選權。
